

VOLUNTEER AGREEMENT AND RELEASE

I, _____ agree to release, discharge, indemnify, and hold harmless Fairy Tails for any and all damage to my personal property while performing my volunteer services with Fairy Tails in a volunteer capacity. This may also include assisting in adoptions of pets through Fairy Tails at local PetSmart stores. I recognize that in handling animals with Fairy Tails while performing my volunteer services, there exists a risk of injury, including personal, physical harm. On behalf of myself, my heirs, my personal representatives and executors, I hereby release, discharge, indemnity and hold harmless Fairy Tails, its agents, servants, and employees and PetSmart from any and all claims, causes of action or demands, of any nature or cause connected with my Volunteer Agreement and Release. This might include costs and attorneys' fees and court costs incurred by Fairy Tails and/or PetSmart in connection with my volunteer services based on damages or injuries which might be incurred or sustained but are not limited to animal bites, scratches, accidents, injuries and personal property damage.

I understand that if I am participating in a Roadway/Roadblock Fundraiser, I will be bound by the following terms:

Volunteer Waiver form must be signed by parent or guardian if volunteer is under 18.

(Parent or guardian may be called for verification.)

Volunteer Waiver form must be given to Fairy Tails Representative before Roadblock.

All volunteers required to wear Fairy Tails shirt (red) or a safety vest for safety.

A minimum of two volunteers must be present at Roadblock. Volunteers must work in pairs. No volunteer should be on the road alone. Adult supervision will be present either by parent, guardian or Fairy Tails representative.

I understand that public relations is an important part of volunteering with Fairy Tails. I, therefore, agree on behalf of myself, my heirs, my personal representatives, and my executors, to allow Fairy Tails to use any photographs taken of me for use in public relations efforts. Fairy Tails will use reasonable efforts to notify me before use, but such notification is not a condition of photographs being released for public relations purposes.
